



## Senior Clinical Therapist

### Supporting Youth and Families as They Navigate Life's Challenges

360 Youth Services, a non-profit agency transforming the lives of youth for almost 50 years, is looking to hire a **Senior Clinical Therapist** to support youth and families.

This **full-time (40 hours/week)** exempt position is a member of the agency's Counseling Department. Our ideal candidate is fully licensed and enjoys **variety** in their week and case load. Our staff work with office based youth as well as provide services within a school setting 2 days a week. Additionally, our team participates in on call hours each week to assist the local community with youth who have runaway or have been locked out of their home.

We are looking for a clinician that has several years of **clinical experience** related to working with youth in between the ages of 10 to 25 as well as with experience in providing effective **family therapy**. Ideally the candidate has experience or knowledge related to working with youth that have experienced **complex trauma** and **providing affirming counseling with Black, Indigenous and People of Color (BIPOC) and the LGBTQ+ population**. The ideal candidate can nimbly **adapt** to providing services in many contexts and with youth and families that present with a wide range of concerns such as depression, anxiety, drug use, running away, fighting, and trauma. Our therapists are **team-oriented** while also being **self-motivated** and **self-aware**.

#### Senior Clinical Therapist Duties & Responsibilities:

1. Using a trauma informed approach, provide individual and family counseling services to youth and families between the ages of 10 and 25 that present with a wide range of concerns, such as family conflict, delinquent behaviors, depression, trauma, and anxiety.
2. Be able to effectively provide counseling services, often short term, in a school setting with middle school aged or high school aged youth to help them learn skills related to school issues, such as consequential thinking, impulse control, and anger management.
3. Be a leader within our department, offering clinical expertise to members of the department in group meetings and supervisions; provide trauma informed individual clinical supervision to clinicians who are accruing hours and experience towards full licensure as well as an intern clinician completing a masters level internship.
4. To collaborate with community partners, such as DCFS case workers, schools, police departments, juvenile probation, and mental health agencies/hospitals, to serve youth.

5. Provide timely, diligent and confidential mental health records, including work within the eCornerstone data system work for each youth in compliance with DHS and CCBYS (Comprehensive Community Based Youth Services) requirements and agency standards.
6. To provide community information and linkage to referral services for youth and their families for substance abuse, mental health treatment, educational, and employment training programs.
7. To assist with crisis coverage as part of the 24-hour crisis response system for CCBYS as designated by the Clinical Director and provide crisis intervention and advocacy services to at-risk youth with the purpose of family preservation, reunification, and stabilization in office, school and community settings while promoting healthy environments, lifestyles and behaviors using educational and support services to agency clients, which builds the capacities of individuals, groups and families.
8. Attend at least two trauma related trainings per year.
9. All other duties as assigned.

**Relationships:**

1. Report to the Clinical Director. Supervise staff and/or intern clinicians as well as participate in weekly group supervision.

**Qualifications & Characteristics:**

1. **Education:** Master's Degree from an accredited program focused in counseling, psychology, social work or marriage and family therapy required.
2. **Experience:** Must hold a State License: LCPC, LMFT, or LCSW
3. **Competencies:** Must be strength based, understand and follow ethical guidelines, trauma informed, detail-oriented, demonstrate strong problem solving skills, and be friendly and flexible to engage youth.
4. **Technical:** 360 strives to operate from a trauma-informed, anti-oppressive and intersectional lens. Our expectation is that staff will embody these principles and continue to grow and develop in these areas.
5. **Social Skills:** Must be a positive, engaging, open to feedback, collaborative team player with the ability to work independently and take initiative.
6. **Leadership:** Must demonstrate professionalism, flexibility, and good judgment as well as clinical supervisor skills.
7. **Mission-Driven:** Reinforces 360's mission and vision with the organization and the community.
8. **Collaboration:** Engages in team work with both internal staff and outside community members such as school staff, probation officers, and family members of clients.

9. **Personal Growth:** Models adaptability and an awareness of the impact of change. Demonstrates a hunger to maintain and learn skills.

**Special Conditions:**

1. Position requires evening hours for sessions as well as some weekend and holiday on call coverage for the runaway and lockout hotline that we oversee locally.
2. Must have access to a vehicle daily, a valid driver's license, good driving record, and proof of auto insurance.
3. Preference given to candidates: with knowledge and experience working with youth as well as youth who have experienced traumatic stress; previous work experience with CCBYS; knowledge of and commitment to affirming LGBTQ+ youth.

**Salary:** depending on experience, additional specializations, licensure

**Organizational Values:** Our values unite us as an organization. They are the anchors that steer our behavior, interactions with each other, and provide a guide for decision making.
